If you are absent from class on the day or you are unable to attend the class but failed to notify us by phone or fax at least five working days prior to the class date, and you need to arrange make-up class then we will charge you an administrative fee of HK\$200 for each make-up class arrangement.
8. If you are unable to attend class due to illness, you must submit a valid sick leave certificate by fax. We will rearrange your make-up class after your sick leave is accepted. If you request a change after the make-up class date has been confirmed, we will charge you an administrative fee of HK\$200 for each change request.
